Statham Lions Club makes every effort not to have an overabundance of the same type of merchandise. However, we cannot guarantee there will not be duplications. The Statham Lions Club prohibits the use, possession, or sale of any item(s) that it determines are detrimental to the health, safety, or wellbeing of any person. Prohibited items include, but are not limited to, Alcohol, Tobacco, Knives, All Contraband, Pyrotechnical items, Firearms, and any items that realistically resemble firearms.

Vendor spaces are 12' x 12'. Vendors are responsible for furnishing all necessary materials for their space. Drop cords #14-gauge wire or larger is required for spaces with electricity. Food vendors must have a current dated and fully charged fire extinguisher on site (5lb min).

2024 SPRINGFEST - FESTIVAL GUIDELINES

NO REFUNDS DUE TO WEATHER, ANY OTHER REFUNDS WILL BE DECIDED ON BY
THE STATHAM LIONS CLUB FOUNDATION INC.

SPACES ARE ASSIGNED ON A FIRST COME FIRST SERVED BASIS, VENDOR SPACES WILL NOT BE REASSIGNED ON THE DAY OF THE FESTIVAL.

ABSOLUTELY NO VEHICLES WILL BE ALLOWED INSIDE THE FESTIVAL AREA AFTER 8:30 AM.

ABSOLUTELY NO BICYCLES, SKATEBOARDS OR GOLF CARTS UNLESS APPROVED BY STAFF.

THERE WILL BE NO PARKING AT CASTO'S FRONT PARKING LOT AS THIS IS A VENDOR AREA

AFTER 8:30 AM, ALL VENDORS WILL HAVE TO CARRY ALL EQUIPMENT AND SUPPLIES TO THEIR VENDOR SPACE.

VENDORS SHOULD UNLOAD ANY SUPPLIES AND EQUIPMENT AND THEN MOVE THEIR VEHICLE OUT OF THE FESTIVAL AREA TO REDUCE CONGESTION AND TRAFFIC PROBLEMS.

VENDORS ARE ALLOWED TO BREAK DOWN AND LEAVE BEFORE FESTIVAL CLOSES-
HOWEVER, YOU WILL NOT BE ALLOWED TO BRING A VEHICLE INTO THE FESTIVAL AREA DUE TO PEDESTRIAN TRAFFIC.

FOOD VENDORS WILL PROVIDE YOUR UPDATED LICENSES AND PERMITS, AS WELL AS A FIRE EXTINGUISHER (5LB MIN). ON-SITE INSPECTION WILL BE REQUIRED.

FOOD VENDORS (COOKING UNDER A TENT) MUST APPLY FOR PERMIT WITH BARROW COUNTY FIRE MARSHAL AT LEAST TEN DAYS BEFORE THE EVENT- THIS APPLICATION WILL BE SUBMITTED ONLINE AT THE WEBSITE barrowgafiremarshal.org., **THERE IS NO FEE FOR THIS PERMIT.** THERE IS A CHECKLIST THAT FOLLOWS THE APPLICATION FOR YOUR SAFETY.

FOOD TRUCK VENDORS MUST APPLY FOR A PERMIT WITH BARROW COUNTY FIRE MARSHAL AT LEAST TEN DAYS BEFORE THE EVENT. THIS APPLICATION WILL BE SUBMITTED ONLINE AT THE WEBSITE barrowgafiremarshal.org., **THERE IS NO FEE FOR THIS PERMIT.** THERE IS A CHECKLIST THAT FOLLOWS THE APPLICATION FOR YOUR SAFETY.

CHARCOAL, GREASE, COOKING OILS, BY-PRODUCTS, ETC. ARE NOT ALLOWED TO BE DUMPED IN THE FESTIVAL AREA.

VENDORS ARE REQUIRED TO CLEAN AROUND THEIR SPACE AFTER THE FESTIVAL IS DONE. TRASH CANS ARE PROVIDED.

FOOD VENDORS THAT ARE **NOT COOKING** ARE CONSIDERED CRAFT VENDORS. PLEASE BE SURE THE FOOD IS INDIVIDUALLY WRAPPED.
